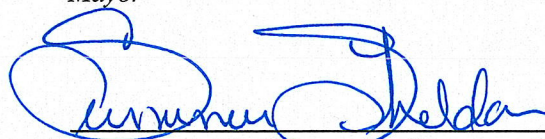
II. Adjournment
