### BEER BOARD HEARING

The Beer Board for the City of Red Bank, Tennessee met in a public and duly advertised Beer Board Meeting on April 16, 2024, at 6:11 p.m. at the Commission Chambers located at 3117 Dayton Boulevard. The date, time, and location of the meeting were advertised in the Chattanooga Times Free Press, on the City's Facebook page, and on the City of Red Bank website together with instructions and an internet link to enable virtual attendance by the public and to allow public access to the agenda and the agenda materials. The purpose of the meeting was to consider application(s) for new beer permit(s). Those in attendance were Mayor Hollie Berry, Vice Mayor Stefanie Dalton, Commissioner Jamie Fairbanks-Harvey, and Commissioner Hayes Wilkinson. Commissioner Pete Phillips was absent. The application and references have been reviewed and preapproved by Administration and the standard permit requirements verified by the Police Department together with the mandatory TBI background check have all been completed with no adverse findings.

Mr. Distefano was present and explained that they intend to sell beer and will mark the perimeter with signs, have security on site to check IDs, and put bracelets on those eligible to purchase beer. Commissioner Wilkinson made a motion to approve the application, seconded by Vice Mayor Dalton, No discussion. No citizen comments. The application was approved with all Commissioners present voting "yes".
